

- Holden Disease Surveillance Report Q1 of 2019 Michael Mendez reviewed
- Emergency Preparedness Michael Mazloff attended the Alliance Meeting, they discussed emergency preparedness and recommended the alliance towns perform a follow up drill for the plan that was put in place. Mike Mendez will ask Katrina to attend the next Board of Health meeting to discuss coordination of the drill. Police Fire and possibly the Light Departments will need to attend as well as the Board members. Michael Mazloff motioned to enter into a secondary emergency preparedness drill. Michelle O'Rourke seconded, Stella Adu-Gyamfi third APPROVED
- Composting Michael Mazloff discussed commercial composting of food waste, it is beginning to become a problem area in surrounding towns, it can cause nuisance with odor and animals. Mike Mendez mentioned there is a bill going through DEP and BOH. Just something to keep in mind going forward.
- Air B n Bs The Board discussed Air B n Bs and the possibility of them in Holden, more of a tax collecting subject. Board of Health could permit them and perform pre-rental inspections, another topic to keep in mind going forward.
