

- **Pool** Holden Community Pool was inspected and passed. Have done multiple drive byes to check for social distancing.

■ Elliott Tree – 94 Wachusett Street

- Phil Leger met with Howard, principal owner Monday morning, August 10, 2020. Howard will notify Phil when the grinder will be coming next so the noise level readings can be taken. Phil will use the new meter from DEP to take the readings. Howard explained the grinder will be there one more time this year. Phil explained to Howard that this is a residential neighborhood around him and the sound of the chipper/grinder is loud for a neighborhood setting, therefore, the readings need to be taken to determine if the noise is above the standard allowed noise level. Howard agreed and said he would let Phil know when the grinder/chipper will be on site next so the readings can be taken. Howard said he usually only gets 2 days' notice but he will let Phil know as soon as he knows.
- Michael Mazloff asked if the grinder/chipper is going to be onsite one more time, is this one more time forever?
- Phil Leger responded No, one more time this year
- Micahel Mazloff asked what happens after the readings are taken.

- Phil Leger answered, if the readings are over the limit we will issue an order to stop the activity
- Michael Mazloff asked Phil if he would have the staff to do the readings with only 2 days' notice.
- Phil Leger answered yes, we hope to have more notice but we will make it work he is talking October so at least we know that much.
- Michael Mazloff asked if there could be communication with Howard to get it in writing that he will give us at least 48 hours' notice
- Phil Leger said he will send him an email
- Michelle O'Rourke said she feels this is a good way to proceed
- Stella Adu-Gyamfi agreed this is a good way to proceed
- Michael Mazloff asked Phil to let the neighborhood know this is how the Board decided to proceed
- Phil said he will send an email to the contact person in the neighborhood letting them know

COVID-19

- Phil Leger reviewed the current Governor's orders with the Board
- Pam Harding informed the Board that Wachusett and Holden schools will be 100% remote learning for the 1st quarter of the school year
- Michael Mazloff asked how the complaints are with people not wearing masks.
- Phil Leger said they slowed down in Holden, as calls come in they have been following up with businesses and letting them know the guidelines
- Pam Harding said the town has been getting inquiries on small camps to drop kids off at during school hours (Pods)
- Phil Leger said there are groups out there doing after school programs for working parents
