## Health Agent Reports/Updates - Danielle Edmands - Regional Environmental Health Specialist

#### Housing/Nuisance

- Received a complaint about Stewart Chocolates on 12/17/20 due to lack of crowd control.
  Danielle spoke with owner about making sure to limit and space out the number of people in the establishment. Signage was posted on the door as to how many people could enter at a time.
- Received a complaint about Big Y on 12/24/20 due to lack of crowd control, mask wearing and social distancing. Danielle did a site visit on 12/24/20 spoke with manager. Observed proper COVID safety guidance at establishment.
- 100 Chapel Street. Housing complaint. Re-inspection scheduled for end of January 2021. Had to reschedule due to illness at the residence.

Danielle did a site visit on 12/29/20 at 19 Harrington Drive. Have closed out the case because the items on the property at this time do not pose a public health risk. Occupant has had communication with the building department to help resolve issue.

- Pam said she would talk to Louise at the Senior Center to find out about storage capacity and approximate numbers of seniors in the age range.
- Pam asked Karyn about the clusters and how they are reported, there have been clusters in Holden that we were not notified about.
- Karyn will talk to the nurses about reporting the clusters to the individual towns.
