Chairman Barnes called the meeting to order. The Board stood to recite the Pledge of Allegiance. She announced that Sel. Bates was participating remotely and confirmed that he could hear the meeting.

2. Appointments, Licenses, and Permits

Motion by Sel. Renzoni, seconded by Sel. Herlihy, it was **UNANIMOUSLY VOTED TO REAPPOINT ROY FRASER TO THE ZBA FOR PERIOD OF TIME FROM 5/31/22-5/31/25 BY A UNANIMOUS ROLL CALL VOTE.** (Renzoni: yes; Herlihy: yes; Barnes: yes Bates: yes).

3. FY 2023 Budget Discussion

Mr. Lukes stated last meeting was the final hearing of Fin Com and they took their final votes. He stated that they came to several agreements in process and at the final meeting the recommendation to reduce contributions to various stabilization funds was made to lower the tax rate. He stated he did not have a final resource profile but the average resident will be lower then it has been in the last few years. The collaboration to find ways to reduce budget and adjust revenue projections to the original budget so that it was not as high as it was in the past. Mr. Lukes stated that this was done looking at the economy as a whole to relieve the increase to the tax bill. He stated that the final budget would be awaiting approval at Town Meeting.

Sel. Renzoni thanked Mr. Tupper for the monthly reports. He stated that Holden's power portfolio has more than half of it attributed to non carbon emitting places. He stated that he appreciated the position that Holden is in for 2050 and the green energy expectations.

Ms. Cole stated they had just got their fourth dog and did not realize that Holden required a kennel license for four dogs or more. She stated this was for non commercial use and applied for the 4-10 dog license just because the process was cumbersome she did not intend to get ten dogs.
