## Vaping Ban and Outreach – Joshan Niroula – Public Prevention Specialist WDPH

- Joshan informed the Board that Danielle hand delivered letters to the tobacco retailers in Holden stating the new state law.
- A hand out of the Scope of Services of the Worcester Division of Public Health/Central MA Regional Public Health Alliance Tobacco Control Program was provided to the Board
- Joshan reached out to the principal of Mountview Middle School to try to set something up
  for vaping outreach he said he would reach back out to her however she hasn't heard back
  from him, she is asking the Board for help. Michelle suggested reaching out to the PTA and
  setting something up through them. Stella said she could help contact the PTA. Pam spoke to
  Colleen Bolen and she suggested doing a town wide event that way you would reach the

whole town not just families with kid's in public schools. Stella thought it might be a good idea to hold something before a sporting event.

 Joshan would like to attend the next Board of Health meeting to discuss possibly amending the Tobacco Regulations.

# New/Other Business

- The EDS Drill will be February 29, 2020 at 9:00 am at WRHS
- Michael Mazloff Plastic Bag Ban Follow Up Michael will be submitting this as a Citizen Petition at the Town Meeting in May.
- Pam Harding DEP is promoting model regulations for commercial haulers, this will provide recycling for commercial buildings, condo and apartment complexes which are not enrolled in Casella municipal trash and recycle. The local regulations would require a public hearing to adopt. This is a big expense right now, not recommended at this time.
- Michael Mazloff Mosquito Control (CMMCP). Because of the EEE concern BOH looked into mosquito control with Central Massachusetts Mosquito Control Project based out of Northborough, MA. The town would be looking at \$106,000 to have this service. Michael drew up a draft and made a motion to accept the draft to move forward as a potential warrant article for the May 2020 Town Meeting. The draft was accepted by the Board unanimously.
