- 469 Bailey Road animal complaint, dead steer in the yard, Julie Vanarsdalen went out to the property to confirm the steer had been properly buried.
- 57 Walnut Street Animal complaint, being rectified.
- Michael Mazloff asked about abandoned homes, can the town or the Attorney General's office condemn these homes? Mike Mendez answered there is a process if the homeowner does not rectify the issues, but if the homeowner does rectify the issues there is no grounds for the town or Attorney General to take receivership.
