Table 1 is a breakdown by source of the energy purchases.



Rebates

MMWEC's NextZero program completed 9 residential home energy audits during the month of April. The total rebates for the month of April were \$3,989.00. HMLD issued \$590.00 in appliance rebates, \$3,000.00 in HEI Rebates and \$399.00 for Wi-Fi thermostats. Cool Home rebates include rebates for high efficiency central A/C and Heat Pumps and HEI rebates are for energy star heating systems, duct sealing, blower door tests, and insulation.
