# Holden Municipal Light Department Monthly Report July 2014

#### **Key Points:**

- ➤ Energy deliveries for July were 11.2% lower than July 2013 and 2.0% higher year to date.
- On a degree-day basis, July was 42% cooler than 2013 and was 1% cooler than a normal July.

## Major events/activities:

- The Light Department recently agreed to buy power in the following quantities and prices:
  - ➤ 1 MW Oct14 Peak @ \$40.75/MWH (4.075 cents/KWH)
  - 1 MW Jun15-Aug15 Peak @ \$51.25/MWH (5.125 cents/KWH)
- The audit by the Massachusetts Department of Revenue of the Light Department's collection of sales and use tax is complete. We received a letter from the DOR accepting "your computation of tax as reported", which is the best outcome possible. The auditor was very complimentary of our processes and diligence and found no issues.




