

Holden Municipal Light Department

Net Metering Rate

MDPU # 134

Effective: November 1, 2019

AVAILABILITY

Applicable to customers who request net metering service from Holden Municipal Light Department. This rate governs certain renewable generation facilities located on a customer's premise, where the Net Metering Facility is owned or leased by the customer, located in the customer premise and used solely for the purpose of the customer's own consumption. Service under this rate is subject to the Department's printed requirements and the Department's Terms and Conditions each as in effect from time to time.

COST OF SERVICE

The monthly charges for service shall be:

The Department shall bill a customer at the designated service rate if in any Billing period, the kWh consumed by the customer exceeds the kWh generated by the Net Metering Facility.

The Department shall credit the customer's account at the designated service rate if in any Billing period, the kWh generated exceeds the kWh consumed by the customer. Net metering customers will receive monetary credits to their electric account for their excess generation based on their class of service.

Upon the customer's request, for the billing period ending in March of each year (or at termination of service), any remaining credit balance in a net metering account will be returned to the customer by check. The customer charge, Net Metering Distribution Charge, and minimum charge associated with the customer's class of service will still apply.

Net Metering Distribution Charge

Net Metering Distribution Charge: \$2.00/ kW multiplied by the DC capacity of the Net Metering Facility

Net Metering Distribution Charge will be applicable for any Net Metering customers effective on or after November 1, 2019. Existing Net metering customers will be charged the Net Metering Distribution Charge on billing periods effective after five (5) years from the Permission to Operate Letter issued by HMLD.

Interconnection

Net Metering customers must complete and sign HMLD's Interconnection Application & Agreement. The Net Metering customer will be required to pay all applicable application fees, meter installation, and electrical permitting fees. Service is subject to HMLD's requirements.

Renewable Energy and Environmental Attributes

For Net Metering customers that are provided grants and/or rebate funds from the HMLD or the Commonwealth of Massachusetts, the Department shall have ownership interest, and title to, renewable energy certificates, or environmental attributes, associated with the energy produced by the Net Metering Facility.

For Net Metering customers with no grant and/or rebates from the HMLD or Commonwealth of Massachusetts, the provisions of net metering services does not entitle the Department to ownership of, or title to, the renewable energy or environmental attributes, including renewable energy certificates, associated with any energy produced by the Net Metering Facility.

TERMS AND CONDITIONS

The Department's terms and conditions in effect from time to time, where or not inconsistent with any specific provisions hereof, are part of this schedule.
