Proper Use and Disposal of Needles and Syringes Be Smart. Be Careful. Be Aware. Be Safe.

If you're one of the many people in Massachusetts who use syringes to manage your health care at home, Here's what you need to know about the safe use and disposal of needles, syringes and lancets (sharps).

Be Smart. Use a Sharps Container.

A sharps container is a single-use container that is filled with used medical needles and then disposed of safely. These can be purchased at medical supply stores or even ordered through the mail.

DO:

- Visit a medical supply store to purchase sharps containers.

DO NOT:

- Put sharps containers in with recyclables.
- Dispose of sharps in garbage if your community has another disposal option (see disposal site list at the end
 of this fact sheet).* If your community does not currently have a disposal site, place them in a rigid, puncture
 resistant plastic container with a secure cap before placing in the garbage.

Be Careful.

Protect yourself, your community, your environment, and family and friends. The proper disposal of needles and syringes is important!

DO:

- Put used syringes in sharps container immediately.
- · Keep needles away from children and pets.
- Bring a sharps container when traveling.

DO NOT:

- Throw sharps in the garbage if your community has another disposal option (see disposal site list).
- Flush sharps down the toilet or drop into storm drains.
- Clip, bend or recap needles.

Sale and Possession of Hypodermic Syringes and Needles in the Commonwealth of Massachusetts (M.G.L. chapter 94C, sections 27, 27A and 32L)

- Individuals 18 years and older may legally purchase syringes and needles from a pharmacy without a
 prescription
- Disposal of syringes must be done safely and responsibly.

State Sanitary Code (M.G.L. chapter 111, section 127A) Improper disposal of infectious or physically dangerous medical or biological waste may result in penalties of up to \$25,000 or two years in a corrections facility

Be Aware.

Needles, syringes and sharps containers may not be thrown in recycling bins. Do not dispose of sharps in garbage if your community has another disposal option (see disposal site list). If you must, place them in a rigid plastic container with a secure cap. These items must be disposed of at a drop off site or through a medical mail back service.

* Effective July 1, 2012, homesharps, as well as unopened packages of hypodermic needles and lancets, shall not be disposed of in solid municipal waste, including household waste, and shall be collected and disposed of in accordance with the requirements outlined in the amended regulations.

Be Safe.

Reduce your risk of blood-borne diseases like hepatitis and HIV/AIDS.

DO:

- Use a new needle every time you inject.
- Clean the injection site with soapy water, alcohol swabs or rubbing alcohol.
- Find out your HIV/viral hepatitis status. Get tested. If you are not infected you can stay that way. If you are, find out how to take care of yourself and avoid passing HIV/viral hepatitis to others.
- Clean your sharps with bleach IF you must reuse them.

DO NOT:

- Inject in the same spot over and over again.
- Share needles, syringes, cookers, cotton or water.
