

Town of Holden Board of Health Meeting November 14, 2017

Called Board of Health Meeting to Order: 5:01 PM

- Jeff Zottoli spoke to the Board with concern of the Beaver Removal Permit Fee increase. He feels residents are already in a hardship and to charge them a \$50 permit fee is hard to do, he doesn't feel it is fair to charge the homeowner \$50. Mr. Zottoli stated that most surrounding towns do not charge a fee ex. Paxton, Princeton, Oakham, Hubbardston. Sterling charges \$10. Mr. Zottoli asked what is involved for the town to do when a permit is applied for. The Board explained the process done to determine the fees. Michael Mendez explained that an application is reviewed by the agent using GIS maps to be sure there will not be a health hazard at the location of the beaver trap.
- The Board discussed Mr. Zottoli's concern and will keep the \$50 fee for Beaver Removal Permits and agreed to review the fees yearly.
