

Housing/Nuisance

- 19 Harrington Ave collecting small engines, concern of emergency staff not being able to get to house in case of emergency. Mike Mendez and Phil Leger went to the home and spoke to the homeowner. He explained he is working on a shed to store things and is working on cleaning up.
- 57 Wahlstrom Lane Child living there was diagnosed with Lyme disease. The mom was told by the doctor to notify the Board of Health. The nurse was notified and will follow up.
- 32 Mt. View Drive Vacant home with overgrowth. Mike Mendez has requested to meet with the homeowners, waiting to hear back.

CMRPHA Report - Michael Mendez - Regional Public Health Specialist

Michael Mendez highlighted some information from the report

- Opioid Epidemic In-Service Staff would like to present on the opioid epidemic at town department head meetings. Pam will look into it.
- MHOA Opioid Tool Kit Mike will find out more about it and review at the next meeting.

- Pam Harding asked Mike Mendez if there is a replacement for Megan Denubila, Mike answered no, not yet. Karyn Clark will cover tobacco until a replacement is found.
- Tobacco Violations AL Prime Energy and One Stop Food Store Both sold to underage, a violation ticket was issued to both.
- 28 Glenwood Street The case went to court on August 31, 2018. A preliminary injunction was issued by the judge for the tenants to vacate the house by September 7, 2018. Mike Mendez and Phil Leger posted the order on the house. An inspection was done, tenants were

- not moved out, a sheriff and locksmith will go Wednesday 9/12/18 to make sure the house is vacated and locks are changed.
- Pam asked Michelle if there was a date set for the next Wellness Committee Meeting.
 Michelle said no she will let us know. Pam would like the nurse for the alliance to attend.
- Michelle will reach out to the guidance counselor at the school about working with the Board of Health on Opioid Issues, etc. Michelle will follow up now that school is back in session.
- 50 Cutler Road Trash, failed septic, boarded windows Michael Mendez, Phil Leger and Pam Harding met with the Attorney General about receivership of property. The Attorney General's office is working on gathering information needed to complete the 1st step which is is a soft demand letter to the homeowner on file. Mike informed the board that it is a lengthy process.
