## FROM THE TOWN MANAGER'S OFFICE ...

The Town has partnered with Wachusett Regional School District to allow for exclusive use of the track at



the high school to senior citizens of **Holden** between the hours of 9:00 AM - 11:00 AM daily. This is intended to give our seniors a place to walk and exercise without worry of interacting with non-masked joggers, strollers, etc. as might otherwise happen on a sidewalk or elsewhere. Seniors wishing to use the track MUST request a parking permit from the Town Manager's office prior to parking and using the track. They can get one mailed to them or arrange to pick it up in person by appointment at the Starbard Building. Visitors are required to display the placard on their dashboard while using the

track. Please call the Town Manager's office at (508) 210-5501 to request the pass or if you have questions. The **Town pool** on Salisbury Street opened on June 12th. Pool passes must be purchased from the Recreation Department in order to use the pool. Mature adults 55 years+ exclusively can swim from 11:00 a.m.-1:00 p.m. Please call the Recreation Dept. at 508-829-0263 for more information on obtaining a pass & COVID-19 pool regulations.

#### INFORMATION FROM SHINE

We want to let everyone know that although our senior center partners are operating on a limited basis due to the COVID emergency, the SHINE Program is continuing to operate. Although we cannot provide office appointments at this time, our counselors are still available to assist you to answer any of your Medicare related questions. You can reach us if: you are aging into Medicare at 65, you have lost your employment coverage for any reason and you are 65 or older, or simply have a general question about your current Medicare coverage. Our counselors, who



are working remotely, will return your call within 1 business day. If you live in Central Mass., call us at 508-422-9931. We are also available via Zoom video conferencing to do one-on-one appointments if needed. In the near future we will be doing Medicare 101 presentations via Zoom. Finally, Medicare and Social Security have announced new procedures for Medicare enrollment during the COVID EMERGENCY. This information is available on our website at www.shinema.org. Trained SHINE (Serving Health Insurance Needs of Everyone) volunteers can help you! They offer free, unbiased, confidential counseling on all aspects of health insurance to anyone on Medicare. During this time, we are not doing face to face appointments. You can call 1-508-422-9931.

In the fall, two important elections are scheduled to take place. There is an expanded opportunity to vote by mail in the upcoming State Primary and Presidential elections. The Secretary of State's Elections Division will be mailing a pre-addressed, postage paid ballot

application to all registered voters. The bill allowing such a mailing hasn't passed at this time but I anticipate its passage. You don't have to wait until the State sends you an absentee application, you can request one now from the Town Clerk's Office. Absentee applications are available at the Senior Center, on the Town Clerk's website or the Secretary of State's website. You can send me a hand written letter or an email stating you'd like a ballot for some or all elections this year. In your request please indicate your choice of political party for the primary, state your residential address and mailing address if it's different from your residential dress and a phone number to call in case we have a question. I hope that everyone will exercise their right to be heard at the polls while staying safe and taking advantage of expanded voting by mail. I hope to hear from you.

#### Covid-19 Crisis

As we practice social distancing to stop the spread of COVID-19 from friends and family, it is easy to become overwhelmed by all the news about the virus. And while most of the country is shut-down, scammers are still hard at work preying on people at their most vulnerable. Using robocalls, email and text messages scammers try to sell fake cures or get access to your personal information

That's why my office is providing important tips to keep you safe from scams and frauds involving COVID-19.

Now is the time to stay vigilant. If you have questions about COVID-19, please look to the professionals, police, public health, your healthcare provider and my office for safe and reliable information as we all work to keep your community safe during this time.

#### **COVID-19 SCAMS**

FAKE VACCINES & CURES: There is no vaccine or cure for COVID-19. Untested medications are a waste of money and could be dangerous to your health.

**TESTING:** Public health officials are <u>not</u> going door-to-door to conduct testing. COVID-19 testing is done through a doctor, by appointment or at the hospital. Do not let anyone in your home who claims to be doing testing and call your local police.

FEDERAL STIMULUS: Federal stimulus money will be automatically sent via direct deposit if you have that information on file with the IRS or through the U.S. Postal Service. **Do not** respond to robocalls, texts or emails regarding these checks.

**DONATIONS:** Be sure to fully vet any donation or cash app requests whether by email, phone or on social media.

Now is the time to stay vigilant & trust the professionals. Police, public health officials & my office have safe & reliable information you can trust.
