#### AVOID BEING SCAMMED ~ PART I...

To avoid scams related to the Economic Impact Payments or COVID-19, The IRS urges taxpayers to be on the lookout for scam artists trying to use the Economic Impact Payments as cover for schemes to steal personal information and money. Remember, the IRS will <u>NOT</u> call, text you, e-mail you or contact you on social media asking for personal or bank account information - even related to economic impact payments. Also, watch out for e-mails with attachments or links claiming to have special information about economic impact payments or refunds.





## NEWS FROM THE HOLDEN COMMUNITY GARDEN

The Holden Community Garden Committee is trying to "get the word out" on the availability of garden plots for Holden residents at the Holden Community Garden (HCG) on 175 Highland Street (Rt. 31/Davis Hill Athletic Field Access Road). Garden plots are open to Holden residents for individual gardening and community gardening projects. Each garden plot is 10 ft. x 18 ft. This year we will be offering 2 "raised beds" which will be at approximately at table height 3 ft. x 8 ft., to allow for better accessibility. The cost to

rent the plots is \$25 per season and includes open use of the land, water and tools on hand. Applications are available on the town website, and any resident who applies is allowed to request a fee waiver if they are experiencing financial hardship.

Often free plants and seeds become available throughout the season. Ethical harvesting is encouraged. By this, the HGC Committee has asked that each participant consider volunteering some time and/or extra harvest from their plot to be donated to community members in need. We grow vegetables together to donate to the Holden Senior Center as well as the Worcester Veterans' Shelter. ## AVOID BEING SCAMMED ~ PART II

Scams related to the coronavirus, also known as COVID-19 are rapidly increasing as the public health emergency develops. Scammers are targeting older adults and those with serious long-term health conditions who appear to have higher risk for serious illness from COVID-19. Fraudsters are attempting to bill Medicare for sham tests or treatments related to the coronavirus and are targeting individuals to illegally obtain money or Medicare numbers. What can you do to stop COVID-19 fraud?

- Do not give out your Medicare number to anyone other than your doctor, health care provider, or other trusted representative.
- Protect your Medicare number and treat your Medicare card like a credit card.
- Never provide your Medicare number to anyone who contacts you through unsolicited calls, texts or e-mails.
- Be cautious of anyone who comes to your door offering free coronavirus testing, treatment or supplies.
- Don't click on links from sources you don't know, which could put your computer or device at risk. Make sure the anti-malware and anti-virus software on your computer is up to date.
- Be cautious when purchasing medical supplies from unverified sources, including online advertisements, and e-mail/phone solicitations.
- Ignore online offers for vaccinations. If you see ads touting prevention products or cures for COVID-19, they are most likely a scam.
- Do your homework before making a donation to a charity or crowdfunding site due to a public health emergency. Be particularly wary of any charities requesting donations by cash, by gift card or wire transfer.
- Be alert to "investment opportunities." The U.S. Securities and Exchange Commission (SEC) is warning people about online promotions, including on social media, claiming that the products or services of publicly traded companies can prevent, detect or cure COVID-19 and that the stock of these companies will dramatically increase in value as a result.

## WHAT DOES MEDICARE COVER IN RELATION TO COVID-19?

- Medicare Part B (Medical Insurance) covers COVID-19 tests when ordered by your doctor or your health care provider on or after February 4, 2020.
- Medicare covers all necessary hospitalizations, including extra days in the hospital for patients who had to stay longer under COVID-19 quarantine.
- There is no vaccine for COVID-19 at this time; however; if one becomes available, Medicare will cover it.
- Medicare also recently expanded coverage to telehealth services to enable participants to access a wider range of services from their providers without having to travel to a facility.

This includes access to doctors, nurse practitioners, clinical psychologists, and licensed social workers. During this emergency, there are also more options for the ways your providers can talk with you under this provision.

# **INFORMATION FROM SHINE**

Are you 65 or older, or eligible for Medicare because of disability? Are you losing your health care coverage from your employer?

If you delayed taking Medicare Part B because you were covered by an employer, but may be losing coverage because of layoff or retirement, contact the SHINE Program, SHINE (Serving the Health Insur

retirement, contact the SHINE Program. SHINE (Serving the Health Insurance Needs of Everyone) can answer your questions. You have a window of opportunity to sign

up for Medicare Part B, if you are losing employer-based coverage. SHINE counselors can explain the process and the forms that need to be submitted to Social Security. They can also review what your medical and prescription coverage options are beyond Medicare Part A and Part B. Call the Central Mass SHINE office at 508-422-9931 and leave a message. One of our counselors will return your call.

Trained SHINE (Serving Health Insurance Needs of Everyone) volunteers can help you! They offer free, unbiased, confidential counseling on all aspects of health insurance to anyone on Medicare. During the current Stay at Home order, our staff and counselors are responding to calls remotely. During this time, we are not doing face to face appointments.

- **NPORTICE** In an effort to assist our residents who have suffered economic hardships during the Coronavirus pandemic, The Board of Selectmen have voted to:
- 1) Extend the deadline for payment of real estate taxes to June 1, 2020.
- 2) Waive interest and other penalty for late payment of any excise, tax, betterment assessment or appointment thereof, water rate or annual sewer use or other charge added to a tax for any payments with a due date on or after March 10, 2020 where payment is made after its respective due date, but before June 30, 2020.

The Board of Selectmen has voted to postpone our Annual Town Election to *Monday, June 22*.
