

Holden Town Clerk Services

Town hall is closed to the public. The Town Clerk's office will be staffed during this time. We will work within reason to accommodate public requests while keeping the safety and well-being of our staff and public in mind.

Below are services the Town Clerk's office provides and is able to continue:

BUSINESS CERTIFICATES (DBA'S, DOING BUSINESS AS)

- Renewals can be done when the Town offices re-open.
- If you are being required to file or show proof of filing, please contact our office.

DOG LICENSING

- You can mail your registration to Holden Town Clerk, 1196 Main Street, Holden, MA 01520, or you can use the drop box at Starbard Building. Address your envelope to the Town Clerk as every department is using the drop box.
- Please make sure to include a current copy of your dog's rabies certificate and a SASE so we can mail the license back to you.

ELECTIONS

- The State House and Senate has filed legislation offering Towns the option of postponing Municipal Elections. We are working to keep the community informed of the status of this decision. - We encourage all who are not able to go to the polls should the election proceed as scheduled, or if the date is postponed to a later date, to submit an absentee or early ballot application. Applications can be found at the Secretary of States website <https://sec.state.ma.us/ele/eleidx.htm>
- If you are not able to print out the application, you may send any written form of correspondence with your signature requesting an Absentee or Early ballot. Please note an Early ballot will be an Absentee ballot but with an Early Voting Envelope. Both will be counted at the polls on election day.
- These requests should be emailed to townclerk@holdenma.gov, or mailed to Holden Town Clerk, 1196 Main Street, Holden, MA 01520 or placed in the drop box at the Starbard Building and addressed to the Town Clerk.

VITAL RECORDS REQUESTS

- Certified copies of Birth, Death and Marriage are \$10.00 per certified copy
- Please contact our office to ensure we have the record.
- Once confirmed, you can go online to request and purchase the record. You can also do so by mailing, or placing a written request in the drop box located at the Starbard Building.
